2. Case deposit e-payment

To pay the deposit of case online, follow the steps below:

- 1. Select the "Case Based Search" option from the Selection Options part.
- 2. In the Enter Case Details part, enter information of the case to which you want to pay the deposit:
 - a. Select the type of the required case from the dropdown list (mandatory field)
 - b. Enter the number of the required case (mandatory field)
 - c. Enter the year of the required case (mandatory field)
- 3. Click on the "Search" button to have the case record displayed in the <u>Deposits part</u>:

Note: When you wish to pay the execution, inheritance, or experts deposits and the payment document is not previously created by the court employee, you can pay part of the remaining amount of the deposit by simply clicking on the "Pay" link, and in the "Pay Deposit " form then you can enter the desired amount to pay and then proceed with the payment procedure.

- 6. Enter the amount that you wish to pay in the "Amount to be paid" field.
- 7. Select the party name for whom you want to pay the deposit from the "Party" dropdown list.
- 8. Make sure that the Email of the selected party is inserted and correct, otherwise, enter the correct Email of the selected party, and then click the "Continue" button.

3. Inheritance deposit e-payment

To pay the deposit of an inheritance case online, follow the steps below:

- 1. Select the "Inheritance Based Search" option from the <u>Selection Options</u> part.
- 2. In the <u>Inheritance</u> part, enter the information of the inheritance case to which you want to pay the deposit:
 - a. Enter the number of the required inheritance case (mandatory field)
 - b. Enter the year of the required inheritance case (mandatory field)
- 3. Click on the "Search" button to have the inheritance case record displayed in the <u>Deposits part</u>:
